BCH-MN President's Report for the 2023 Year

Affiliation with Back Country Horsemen of America (BCHA) identifies us as a responsible voice for recreational stock use on public lands. By affiliating with BCHA as a state chapter in Minnesota, our organization is recognized as a group that seeks to improve trail access for recreational horsemen's use in a responsible and sustainable manner. We also have the backing of both a recognized state and national organization to help us when necessary to accomplish our mission.

We continue to work on increasing membership and establishing new chapters in all areas of our state. Last year, we had our summer rendezvous at Sand Dunes. Projects were identified to improve this campsite and trails, and there was interest in forming a BCHMN chapter to support the



Department of Natural Resources (DNR) in this area. We are very happy to report that a chapter is being started now, and the DNR is looking forward to having Back Country Horsemen support to maintain camps and trails. We will report in more detail on this at our annual meeting.

This year, we have been working closely with the DNR to award us a contract for doing the work we do on trails and in camps. We communicated the types of work we would like to do and now expect to have this in place by spring.

We have members on the BCHA Northeast Public Lands Committee and Volunteer Hours Committee. BCHA members know us personally from our attendance at the BCHA annual meeting, and they have given us a wide range of help with issues.

We welcome input from all our members. There is a place for everyone. There are the boots-on-the- ground projects, as well as members who support these workers by providing food and beverages or even holding horses for members while they complete their work. BCH-MN Expo Booth




